Terms and Conditions

Cancellation

Reservations can be cancelled free of charge up to 45 days before the start of the conference.

If you wish to cancel your registration, you should take into account the following:

You must in any case confirm your cancellation in writing by sending an E-mail to:

If a cancellation is received after the 45 days prior to the start of the conference, Permanent make-Up World Conference shall be entitled to charge 15% of the total price of the reservation.

If a cancellation is received within 30 days before the start of the conference, Permanent make-Up World conference shall be entitled to charge 35% of the total price of the reservation.

If a cancellation is received within 7 days before the start of the conference, Permanent make-Up World Conference shall be entitled to charge 100% of the total price of the reservation.

Refund

In case of cancellation of participation to the conference, Permanent make-Up World Conference will refund the amount with regard to the terms mentioned in section "Cancellation". If for any reason the conference will be cancelled by Permanent Make-Up World Conference, the participant will receive a full refund of the participation fee.

If payment is done by credit card, the refund will be transferred to the credit card account. If payment is done by bank transfer, the refund will be transferred to the bank account of the participant.

The refund will not include travel and staying costs.
